"TOP 6 CLUB SUPERDRAW" RULES

2nd February 2023 - 25th January 2024

- 1. The title of the draw is "Top 6 Club Superdraw", hereinafter called The Draw.
- 2. The are 3 participating Clubs, hereinafter called The Clubs, are: Club North Haven, Club West, Macksville Ex Services Club. Club North Haven has agreed to secure two spots so this will mean that they will contribute two times the start up amount, two times the weekly contribution and two times the yearly invoice fee.
- 3. The Draw is open to all financial members of the participating Clubs who have reached the age of 18 years. Each qualifying member is to be entitled to a membership card, or alternatively a numerical, accountable instrument to be used as proof of membership. The Card is to have a membership number. There is to be one card per member, not to be assignable or transferable.
- 4. Entry into the Draw is free.
- 5. Directors, Management, Employees and Contractors of each of the Clubs are ineligible to enter.
- 6. Any new member of each of the participating Clubs is to wait 7 days from the date of membership acceptance to be eligible for The Draw.
- 7. At the end of each Clubs membership year, any member will be excluded from The Draw if their membership has not been renewed.
- 8. All Clubs are to keep a Register of Members. A central Register of all these details are to be held at and maintained by Club North Haven.
- 9. All Clubs are to notify Club North Haven of all new members each month following acceptance of the member to the club by way of an updated Register of Members, please email this report to andy@clubnorthhaven.com.au
- 10. All participating clubs are to pay Club North Haven a fee of \$300.00 per annum inclusive of GST for administration expenses. Club North Haven will invoice each participating club.
- 11. The Draw will be conducted each Thursday between the hours of 6pm and 8pm at Club North Haven. Members drawn must be on the premises at the time the draw has been conducted and may not enter any Club after the draw to claim the jackpot.
- 12. Club North Haven will firstly draw for a participating club, then a financial member of that club, and then instruct the contact person via telephone to announce via Public Address system the membership number and name of that member of that club. The member drawn will be allowed a period of 4 minutes to present themselves to the contact person and confirm their identity and membership status to the contact person in order to claim the jackpot. A phone through procedure will be then undertaken to advise all other participating clubs of the result of the Draw.

- 13. The drawn member number and member name are to be announced via Public Address System in each of the participating clubs, and the result as to whether the jackpot prize has been claimed or unclaimed.
- 14. Each participating club will deposit into an account held by Club North Haven an amount of \$1000.00 (however, in the case of Club North Haven they will deposit two lots of \$1000) at the start of the permit. The prize will start at \$4,000.00. If unclaimed, the Draw will jackpot by \$1000.00 per week. Each participating club will then deposit into the same account each week an amount of \$250.00 (however, in the case of Club North Haven they will deposit two lots of \$250.00 each week).
- 15. Once the Draw has been claimed, the Draw will restart with a value of \$4000.00, with each participating club to deposit an amount of \$1,000.00 (however, in the case of Club North Haven they will deposit two lots of \$1,000) into the nominated bank account, with weekly deposits from then on to once again be \$250.00 (however, in the case of Club North Haven they will deposit two lots of \$250.00).
- 16. The first Draw is to take place on Thursday 2nd February 2023 and will continue on every Thursday for a period of 1 Calendar Year. The final date of the Draw will be Thursday 25th January 2024, at which time successive draws will take place in the manner described until the prize is claimed. If on the final day of the draw the prize has not been claimed by 11.50pm, the last Club drawn out will be deemed the winning club and the closest number to the member number drawn will be deemed the winner. If by chance there are two winners the same amount of numbers apart from the drawn number the prize will be equally divided amongst the two members. A new permit will at this time need to be sought for the following calendar year.
- 17. Any Prize will be deposited to the winner in the form of a Electric Funds Transfer within 7 days of a valid claim, with the winner's name to be published on the noticeboard of each club.
- 18. All Clubs will deposit into an account separately held by Club North haven. All deposits will be made payable to Club North Haven for the purposes of being deposited into that account. Upon signing the agreement between the Clubs, all clubs will be bound to participate for the entire duration of the draw permit. Each Club must ensure that payments are made on time. Agreements to participate in the "Top 6 Club Superdraw" will be signed by each Club and filed at Club North Haven.
- 19. All Clubs are to be responsible for their own advertising, subject to any advertising containing the NSW Permit Number TP/01604
- 20. A meeting may be called by any of the clubs at any time, with sufficient notice to be deemed not less than 7 days. All meetings are to be held at Club North Haven. One delegate is to be nominated from each participating club to facilitate a meeting. A majority of Clubs is to constitute a quorum. Should a quorum not be present after 15 minutes of the set date and time of the meeting, those present and entitled to vote will conduct the meeting.
- 21. A copy of these rules is to be displayed prominently in all participating Clubs.
- 22. The assets as well as the liabilities of the account will remain the property of Club North Haven.
